1. DEFINITIONS

In these terms and conditions:

'Blunt Pacers', 'we' or 'us' means the business Blunt Pacers with the entity name of M.P Fitzsimmons & R.J Whittington registered with the ABN 74 205 016 573

'the artist/s' includes all persons who submit an application

'Application' includes artworks, concepts and personal information.

'Project' is Pocket-Sized Precincts

2. GENERAL

2.1 These Terms and Conditions apply to any persons that submit an application

2.2 These Terms and Conditions may be amended periodically and you will be deemed to have accepted any amendments if you use the website after those amendments have been posted.

3. ELIGIBILITY

3.1 The Artist/s must

3.1.1 Must over 18 years of age.

3.1.2 Must be an Australian resident for tax purposes.

3.2 Concepts submitted must

3.2.1 Be of an original nature

3.2.2 Fit into the provided casing.

3.2.3 Be suitable for all ages.

3.2.4 Not be exhibited previously.

3.3 Previous artworks submitted as support material must

3.3.1 Be the artist's original work.

4. APPLICATION REQUIREMENTS

Each application must complete the following to be eligible for this project.

4.1 The Artist must submit an application by the online application form by midnight EST on Friday March 4, 2017.

4.2 The Artist must fill in all questions on the form.

4.3 Blunt Pacers reserves the right to not accept applications after the closing date.

5. SELECTION

5.1 Blunt Pacers will select the Artist/s based on concepts and suitability for the project.

5.2 If Blunt Pacers consider that no Artist suitable for the project, no artist will be selected.

5.3 The decision made by Blunt Pacers is final.

5.4 While it is expected that these conditions will be strictly observed, Blunt Pacers reserves the right to waive compliance with or alter any conditions.

5.5 The Artist/s selected

5.5.1 Will receive a payment \$250 for the artwork. The Artist/s will need to submit an invoice to receive payment.

5.5.2 Will receive up to and including \$100 for reimbursements of materials upon submission of receipts.

5.5.3 Should obtain their own professional advice in respect of any tax implications.

6. INTELLECTUAL PROPERTY, COPYRIGHT AND OWNERSHIP
 - 6.1 All designs and artwork prepared and developed by Blunt Pacers shall be the absolute property of Blunt Pacers, unless otherwise agreed.
 - 6.2 All previous artwork and concept work is the sole property of the Artist/s.
 - 6.3 All final artworks created within the project for the quest will be the sole property of Blunt Pacers.
7. PUBLICITY & PROMOTION
 - 7.1 By submitting an application, the Artist/s grant Blunt Pacers a license to reproduce any artworks by print or electronic media leading up to, for the duration and thereafter, to further advertise and other ways publicise the project.
 - 7.2 It is expected that the Artist/s will be selected by March 20, 2017.
8. PRIVACY
 - 8.1 Blunt Pacers is committed to protecting your privacy.
 - 8.2 Your information will not be shared with any third party organisations unless order is made through third party website, whereby you will be subject to their terms and conditions.
 - 8.3 Once details are submitted the artist may be added to our mailing list.
 - 8.3.1 If you do not want to be added, please indicate when applying.
 - 8.3.2 You can unsubscribe at anytime.
9. FORCE MAJEURE
 - 9.1 Blunt Pacers and the artist shall not be liable for any failure or delay in supply or delivery of products/services where such failure is wholly or partly due to any causes outside the reasonable control of Blunt Pacers and the artist including but not limited to war, strikes, lockouts, industrial disputes or unrest, government restrictions or transport delays, fire, power outages, failure attributable to hosting suppliers, breakdown of plant, theft, vandalism, riots, civil commotions, accidents of any kind or act of terrorism.
